We all know a family member, friend, or coworker who has fallen on hard times and needed legal assistance. By addressing the legal issues that threaten stability, **LSSM** keeps families together, housed, safe, and fed, often preventing them from needing other community services.

Every day, this work changes lives. For many families, it is not only life changing, it is life saving. One such family is represented in the letter below. While we have changed the name to protect the client's identity, "Mary Johnson," her grandson, and her family remind us why the mission of **Legal Services of Southern Missouri** is so critical. Mary's grandson was abandoned at birth and left at the hospital without even the most basic proof of identity. Without legal assistance, she could not obtain a birth certificate, the first step in a long and overwhelming adoption process. Because of the compassionate support of Legal Services, Mary was able to adopt, protect, and provide for the child she had cared for since birth. Her words capture what this help meant to her family, and why your support makes such a difference for families like hers.

To all the people at Legal Services, I say thank you.

I cry as I write this letter because of what you have done for our family. The little boy we adopted was my daughter's son. He was born addicted to meth, and his parents abandoned him right after birth.

Since we live on a fixed income, there are days when my husband and I go without so that we can provide for our grandson. The county courthouse gave me your number, and you provided me with an attorney who was a Godsend. I cannot thank you enough for what you did for our grandson and for our family. You saved his life.

I just want you to know how important your work is. You make such a difference. Sometimes I feel so tired, but then I remember people like you who give everything you have to help families like ours.

Thank you, from the bottom of our hearts.
